**Revised Applications Project Update
New State Approvals in August: **IL and PA****

As announced in previous communications, the AIG American General Life Companies have revised and refiled our life insurance application forms. This update is to notify you of state approvals received in the month of August.

State Approvals

The following states have now approved the revised forms: **IL and PA**.

The revised applications are now approved in **all** states in which they were filed.

States already approved: AL, AK, AZ, AR, CA, CO, CT, DE, DC, FL, GA, HI, ID, IN, IA, KS, KY, LA, MA, ME, MD, MI, MN, MS, MO, MT, NE, NV, NH, NJ, NM, NY, NC, ND, OH, OK, OR, RI, SC, SD, TN, TX, UT, VT, VA, WA, WV, WI and WY. (See attached grid for form numbers.)

Transition Rules

- ◆ Old forms will no longer be accepted after November 1, 2007, for **Illinois and Pennsylvania**.
- ◆ The revised applications are now approved in all states in which they were filed.

Accessing New Forms

The revised forms are now available on FastForms Web. Please note: On FastForms Web, both versions of the Part A (Common and Term) are automatically packaged with the Bank Draft Authorization, Notice to Proposed Insured(s) and the Limited Temporary Life Insurance Agreement and Receipt. The Part B and the Child Rider Attachment are the only forms that need to be ordered separately.
